**Subject:** Stoney Blevins, Assistant County Manager, Permit to re-drill a well Debacle.

Stoney Blevins is the Haywood County Assistant County Manager (still working on how that came to be). He also works part time as Director for Haywood County Social Services (DSS - HHS).

Stoney Blevins appears to be in charge of a whole bunch of mystery stuff in the Old Walmart Building, including something called Environmental Health. This is under his DSS hat. These folks, county employees, issue permits to drill wells. The following is a rough pecking order of this little organization, starting at the bottom.

- Adam Jones - Inspector.
- Pam Henson - not sure what her responsibility is at this point.
- Steven Valentine - Environmental Health Supervisor
- Carmine Rocco - Director, Health Department.
- Stoney Blevins - Assistant County Manager, DSS Director.
- Paul Turner - Chair, Haywood County Board of Health.

A Haywood County Taxpayer was lamenting to me of some difficulty he was having with Environmental Services. His grandmother's well was going dry, 4 ounces being pumped every nine (9) minutes. He brought out a well drilling company guy to confirm the problem. Need to re-drill the well, he said, but good luck. You need a permit, and it will be three weeks before these county guys give you a permit.

As I was making make some inquiries into this matter, Stoney Blevins told me point-blank to blow-off. He said:

[“Many of the questions/ concerns you raise concern a matter with a private citizen. Since no citizen has asked us to discuss their business with you as their authorized representative, we will not do so. I believe you would appreciate the same consideration if you had business with our agency and someone wanted us to discuss your affairs with them.”](#)

This response and attitude appear to be coming from someone with a typical DSS mentality.

- “It’s none of your business.”
- “Don’t you worry, we will handle this internally, and you will never know what we have covered up.”

This is a county operation, staffed by county employees, paid out of your taxes through the County Budget. How would you like to be treated if you were making an inquiry on behalf of someone who may be too afraid to stand up to these people.

“Stoney”. Interesting name. After this blow-off, it seems more appropriate to that he be referred to as “Stonewall” Blevins.
