I agree to cooperate by furnishing to the representatives of the North Carolina State Bar all pertinent information and records in my possession concerning the alleged misconduct of said attorney. I further agree that if a hearing or inquiry is ordered concerning the alleged misconduct of said attorney, then I will furnish evidence concerning the facts by submitting to deposition or personal attendance at the hearing or inquiry. I hereby indicate that this information is provided and transmitted by me to the North Carolina State Bar for the purpose of investigating the alleged misconduct of the above named attorney. I understand that I may also need to reveal this information to a privately-retained attorney to pursue private remedies on my behalf. I further understand that the immunity granted by North Carolina General Statute 84-28.2 applies only to those statements made without malice and intended for transmittal only to the North Carolina State Bar.

I also understand that the North Carolina State Bar may reveal this information to the accused attorney for his response to a formal inquiry and to others pursuant only to the Rules and Regulations of the North Carolina State Bar.

The information in this complaint raises questions of whether Mr. Stark violated the North Carolina Rules of Professional Conduct, as more specifically set forth herein, or in the alternative, whether Mr. Stark exhibited bias and a conflict of interest which significantly impaired his professional judgement, performance and competency as an attorney, and whether Mr. Stark had engaged in conduct which is contemptuous and considered contrary to community standards of justice, honesty, or good morals, in attempting to embarrass, delay or burden me, as a third party, and prevent me from my duties as a lawfully elected Precinct Chair of the Allens Creek Precinct in Haywood County.

### **RULE 4.4: RESPECT FOR RIGHTS OF THIRD PERSONS**

(a) In representing a client, a lawyer shall not use means that have no substantial purpose other than to embarrass, delay, or burden a third person, or use methods of obtaining evidence that violate the legal rights of such a person.

### A. BACKGROUND INFORMATION

Certain factions within the HCGOP organization had become dissatisfied, which I will label Establishment vs. Conservatives. The Establishment group started plotting to vanquish the Conservative Group.

Exhibit 1, dated 1/11/2017, is my unofficial roll call of Officers and Precinct Chairs (and Vice Chairs), all voting members.

HCGOP held Precinct Meetings on 2/4/2017. It was at these precinct meetings that Ken Henson, Debbie King, Lynda Bennett and Pat Carr orchestrated a take-over of most of the Precinct Chairs and Vice Chairs. I, and two other people, Jonnie Curie and Barbara Buck, remained as Precinct Chairs. This entitled all three of us to remain voting members at HCGOP Executive Committee meetings. During the actual precinct meetings," recommended" voting guides were distributed by Lynda Bennett. **Exhibit 2** shows the "recommended" voting guide for Allens Creek. I am not even on the recommended list, but I managed to obtain the most votes for Precinct Chair.

**Exhibit 3** is an announcement for the 2017 HCGOP Party Convention. Tom Stark attended this convention, and provided legal / parliamentary guidance during this convention. It was at this convention that Kevin Ensley [RINO], motioned a slate of officers to be nominated, and Pat Bennett, Lynda Bennett's husband, motioned to close the nominations, and boom! It was done. Michele Nix, NCGOP Vice Chair, also in attendance, indicated she had no problem with this sneaky procedure.

There was considerable discourse over social media after the convention, aimed at several people. Ousted HCGOP members formed a new organization, The Haywood Republican Alliance. HCGOP members prevailed upon Tom Stark to write several letters - NOTICE OF TRESPASS, ALL NORTH CAROLINA REPUBLICAN PARTY PROPERTIES AND EVENTS.

**Exhibit 4** is such a Notice to Jeremy Davis, aimed a preventing Jeremy Davis and Eddie Cabe from attending the Republican State Party Convention, June 2-4, 2017.

Jeremy Davis conferred with the Haywood County Sheriff's Department, and Jeff Haynes, Chief of Deputies, indicated that the Sheriff's Department would not enforce this threat, i.e. NOTICE OF TRESPASS.

An HCGOP meeting was held on 7/13/2017 at the Juke Box Junction. Notes and minutes are contained in **Exhibit 5.** On the advice of Tom Stark, HCGOP created a PETITION BY CERTAIN MEMBERS OF THE HAYWOOD COUNTY REPUBLICAN PARTY EXECUTIVE COMMITTEE, **Exhibit 6**. This was to be a special called meeting to be held on August 3, 2017, for the purpose of holding a hearing to remove me as Allens Creek Precinct Chair. Ted Carr handed me a personal copy of this Petition as I was exiting the meeting.

I received a NOTICE OF HEARING on 7/20/2017, Exhibit 7.

The Hearing was held on August 3, 2017. **Exhibit 8.** Tom Stark had dispatched a subordinate, John Lewis, to chair the meeting. **Exhibit 9.** There were two (2) Sheriff's Deputies at the meeting. I attempted to record the proceedings, but was escorted out of the meeting by Aubrey Woodard and the two Sheriff's Deputies. The reason - Trespass. I was not allowed to attend any portion of this "fair and open hearing". The result of this hearing (hearsay), is that I was removed from my duly elected position of Allens Creek Precinct Chair.

I did have my recorder running at the beginning of the meeting, and captured the minute and half or so of my interaction with Aubrey Woodard (District 11 Chair) and Haywood County Sheriff's Deputies. **Exhibit 10.** 

I did not, nor after multiple repeated attempts, nor have ever been provided written notice of the results of this "fair and open hearing". This forms the beginning basis for my multiple e-mails to HCGOP / District 11/NCGOP in obtaining such written notice, and ultimately, the basis for Tom Stark sending me a NOTICE OF TRESPASS, dated 3/20/2018. To this day, I have not seen any of the charges that were presented at that hearing.

I then received a letter from Tom Stark, dated 9/28/2017, **Exhibit 11**, informing me and four other Haywood County Republicans, of Party Disloyalty. These charges would be brought up at the upcoming NC Republican Party Executive Committee meeting in Cary on 11/11/2017.

I subsequently received an extensive packet of CONFIDENTIAL INFORMATION to be presented at the meeting. **Exhibit 12.** One of the documents contained in the packet was a RESOLUTION ADOPTED BY THE EXECUTIVE COMMITTEE OF THE NORTH CAROLINA 11<sup>TH</sup> DISTRICT REPUBLICAN PARTY. It was blank, i.e., there were no signatures. I did not, nor after multiple repeated attempts, nor have ever been provided with any copies of this resolution that were actually signed by anyone. This forms a continuing basis for my multiple e-mails to HCGOP / District 11 / NCGOP in obtaining such proof that this resolution was actually signed by anyone, and ultimately, the basis for Tom Stark sending me a NOTICE OF TRESPASS, dated 3/20/2018. To this day, I have not seen any resolution by the 11<sup>th</sup> district that had been signed by anyone.

Furthermore, the Cary Executive Committee meeting was under strict confidentiality. Rumors and hearsay indicated that I, Richard West and Eddie Cabe had been banned from Republican Party activity for five (5) years. Jeremy Davis was banned for three years, and Paul Yeager was not banned. I did not, nor after multiple repeated attempts, nor have ever been provided with any official notice that I had been banned from party activity for five years. This forms a continuing basis for my multiple e-mails to HCGOP / District 11 / NCGOP in obtaining such proof that I had indeed been banned, and ultimately, the basis for Tom Stark sending me a NOTICE OF TRESPASS, dated 3/20/2018. To this day, I have not seen any written notice that I have been banned for Five years.

On or about 11/14/2017, I began sending e-mails to various party officials, attempting to gain clarification of my status with the NC Republican Party. **Exhibit 13**, show e-mail dialog between 11/14/2017 - 3/21/2018.

The HCGOP held only a couple of Executive Committee meetings, but used any and every means possible to attempt to remove me or have me removed from attending these meetings. One meeting that I was asked to leave the meeting, was held on 11/6/2017 by a motion from Ted Carr. **Exhibit 14.** The minutes show two things:

- I was addressed as a guest, as: "Ch. Monroe Miller AC". Lynda Bennett had addressed me as the current Precinct Chair of Allens Creek.
- The minutes state: "Monroe Miller requested that the Decision be put into writing and sent to him". This was not the Decision about this meeting and why I was being thrown out, but I wanted it in writing that I was removed as Precinct Chair at the August 3, 2017 HCGOP "hearing".

Things came to a head with the e-mail dialog, when I was invited to attend the Haywood County Convention on 3/20/2018, with a special e-mail invitation from Ken Henson, HCGOP Chair to attend the convention. **Exhibit 15.** A particularly nasty response by Dallas Woodhouse finally prompted Tom Stark to issue me a NOTICE OF TRESPASS, EXHIBIT 16.

### CONDUCT WHICH MAY SUPPORT IMPOSITION OF PROFESSIONAL DISCIPLINE.

The following conduct raises questions of whether Mr. Stark may have violated the North Carolina Rules of Professional Conduct, or in the alternative, whether Mr. Stark is exhibiting a bias or conflict of interest which significantly impairs his professional judgement, performance or competency as an attorney by use of means that have no substantial purpose other than to embarrass, delay, or burden a third person.

The NOTICE OF TRESPASS issued by Tom Stark, essentially the same notice that had been sent to Jeremy Davis and Eddie Cabe on 5/15/2017, accused me of *libel per se*. Libel, as I understand it, is where you write something false about someone else. Well, there is nothing in the e-mail dialog, on my website <a href="https://www.haywoodtp.net">www.haywoodtp.net</a>, or anywhere else that I have written libel. Stark has made a false accusation.

The NOTICE OF TRESPASS has not been issued by a judge. In my world, a lawyer can only express an opinion, it is the Judge that makes the Ruling. Tom Stark's letter is simply an opinion and a threat, and I don't appreciate threats.

The Haywood County Sheriff's Office had been apprised of the letters of NOTICE OF TRESPASS sent to Jeremy Davis and Eddie Cabe. The Sheriff, through the Chief of Deputies, Jeff Haynes, indicated that they would not enforce the NOTICE OF TRESPASS in Haywood County.

All throughout my e-mails to HCGOP, District 11 and NCGOP, the central theme repeated at nauseam, were questions related to the HCGOP "fair and open hearing" which allegedly removed me from my elected position as Allens Creek Precinct Chair, and the NCGOP hearing which allegedly convicted four of the five "HAYWOOD 5" of party disloyalty. Specifically, I asked for the following in a majority of my e-mail communications:

- Signed Resolutions from District 11, which should have been presented to the Executive Committee,
- Signed Resolutions from HCGOP, which should have been presented to the Executive Committee,
- An indication if you, Robin, knew how to use e-mail and were going to send the Haywood 5 notice that four of us have been banned and one had been dismissed,
- Could you have either Tom Stark or "Dallas Woodhouse here" send us a copy of the affidavit with the Notary Seal?,
- Can you urge Kebbie (i.e. Ken Henson and Debbie King) to send me an official notice from the "Fair and Open Hearing" HCGOP Kangaroo Court Closed Meeting of August 3, 2017, you know, the one you send John Lewis to chair the meeting,
- Your concurrence that Ken Henson should resign as HCGOP Chair for being a hypocrite regarding the Ted Carr fiasco of getting reimbursed for selling T shirts at the Haywood County Fair that he personally bought in advance.

In a particularly testy e-mail response from NCGOP Executive Director, Dallas Woodhouse, on 3/18/2018, EXHIBIT 13, copied to Tom Stark, is both an incoherent tantrum and threatening. Dallas Woodhouse said:

Miller: You are currently under a No Trespass Order than you are legally prevented from attending this or any other NCGOP event on properties we maintain and control.

You have no legal right to attend, no do we have any obligation to provide you anything and we will not be doing so. This as forwarded to the local authorities, is a legal notice for you to stay away from our

property. We have told you this many times before and you have been served legal notice via courier.

We are a private organization and have full control who is invited to our events and who is not.

You are not invited. You have been served multiple legal notices that you are banned. Should you defy these legally binding orders we will have you arrested.

You may also take this as legal notice that your continued emails to me, Chairman Hayes, our local and/or State Officers are not welcome and constitute harassment.

You are bound under multiple state and federal cyber-stalking and other laws to stop this. We have no desire to communicate with you on any matter, now or in the future.

We have met our legal obligation to inform you of this MULTIPLE times. We demand you leave us alone.

This is notice once again that you are to CEASE AND DESIST contacting myself, Robin Hayes, Michele Nix, any and all officers of the North Carolina and Haywood County Republican parties.

Should you not do so, we will seek a restraining order and work to have you prosecuted under the full extent of the law.

As the North Carolina Republican Party Executive Director, I have the legal authority on these matters as granted to me by the North Carolina Republican Party.

Once again, we demand that you stay away from our events and properties and leave us alone.

Dallas Woodhouse

North Carolina Republican Party Executive Director.

When advised that I had never received a No Trespass Order, Dallas Woodhouse continued the same day with another e-mail, again copying Tom Stark:

If you have not received one. You will receive one This week. And this is your final warning to stop Contacting us.

Sent from my iPhone

Tom Stark, who allegedly does not get paid for what he does for the NCGOP, was taunted by the Dallas Woodhouse tantrum to jump into a Bear Trap - SNAP! Tom Stark was ordered by this character Dallas Woodhouse, for the primary reason of preventing me from attending the HCGOP Executive Committee Meeting on 3/20/2018. Since this was being held in Canton, the NOTICE OF TRESPASS order would have been enforced by then Police Chief Brian Whitner, who has since resigned, not the Sheriff's Department.

- The 2017 North Carolina Republican State Party Convention, State Central Committee and State Executive Committee Meetings to be conducted on June 2-4, 2017 at the Wilmington Convention Center located at 515 Nutt Street, Wilmington, North Carolina 28401; and at the Hilton Wilmington Riverside located at 301 N. Water Street, Wilmington, North Carolina 28401

You recent computer postings, disparaging the leadership of the Haywood County Republican Party, appear to constitute *libel per se*. In addition, please note that your discourse, in particular with female members of the Party, is offensive to our female members and to delegates to the State Convention. I note that you are not an elected delegate to the convention. The Party has determined, based on the foregoing and other action that is not expressly enumerated, that you should not attend the convention or appear at the other locations indicated.

Subject: Summary of HCGOP Meeting of July 13, 2017

A HCGOP meeting was held at the Jukebox Junction on 7/13/2017 at 6:30 pm. It was attended by about 15 people. The number of people attending these meetings is dwindling each meeting. Excluding Jonnie Cure and myself, there were nine (9) voting members, one more than the required eight for a quorum.

Ken Henson started the meeting late again, at 6:38 pm. This meeting, I had my recorder on, as CHARLES DOUGLAS WRIGHT was present again.

Eddie Cabe had asked me to read a letter he sent to Tom Stark, NCGOP General Counsel, and I was going to use the Approval of Agenda item to add it to the agenda, but there was no Approval of Agenda slot on the agenda. I asked Ken about it, and he huffed - "We're not going to do that,"

Mr Stark,

This is a Rebuttal and appeal of your letter of May 16, 2017 regarding alleged misconduct, which I deny except for some items posted on Facebook. I fail to find that you have complied with the basic rights of all respondents, in your communication; including but not limited to: A right to confront witnesses, a public hearing, a right to counsel and a right of appeal.

HEARSAY is not evidence of anything except gossip and your generic complaints seem to be based solely on verbal utterance. If not, I request all written correspondence, including emails, where I am mentioned by name. Your letters are apparently without authority and I will ignore them until you produce, not only regulatory or legal authority but approval by a duly constituted committee of the NCGOP, specifically designed to investigate complaints on me.

Members of political parties are not pawns to be moved on a board but are, as you, dedicated to the attainment of political and governmental objectives. 

# RULES FOR THE HAYWOOD COUNTY EXECUTIVE COMMITTEE MEETING AUGUST 3, 2017

### Statement of Purpose

It is the purpose of these Rules to provide for a fair and open hearing regarding the Petition to Consider Removal of Monroe Miller from the Haywood County Executive Committee in a manner that facilitates the business of the Committee, respects the rights of Monroe Miller and the Haywood County Republican Party.

### Convention Officers Rule1

- (A) The Officers of this Executive Committee Meeting shall be the Meeting Chairman John Lewis, the Haywood County Executive Committee Secretary and a Sergeant-at-Arms to be appointed by the Meeting Chairman.
- (B) The Meeting Chairman may appoint Assistant sergeant at arms as necessary.
- (C) The Meeting Chairman shall be tasked with distributing, collecting and counting the ballots when a formal vote is taken. The petitioners and Monroe Miller may appoint one (1) person to observe the tallying of the votes by the Meeting Chairman. Such appointed observer shall be a member of the Haywood County Executive Committee.

### Representation of Interested Parties Rule 2

- (A) During the hearing of the Petition to Consider Removal of Monroe Miller from the Haywood County Executive Committee, the interests of the petitioning parties shall be represented by their designee. The designee of the petitioners shall be a member of the Haywood County Executive Committee.
- (B) During the hearing of the Petition to Consider Removal of Monroe Miller from the Haywood County Executive Committee, the interests of Monroe Miller shall be represented by Monroe Miller, or his designee. The designee of Monroe Miller shall be a member of the Haywood County Executive Committee.

### Order of Business Rule 3

The order of hearing on the Petition to Consider Removal of Monroe Miller from the Haywood County Executive Committee shall be as follows:

(A) The Meeting Chairman will instruct the Members that the meeting shall be held in executive session in that the meeting involves disciplinary matters. Executive

- session means that all matters discussed, and all evidence presented shall be confidential and not communicated to anyone outside the Meeting room.
- (B) The Meeting Committee Secretary shall read the Petition to Consider Removal of Monroe Miller from the Haywood County Executive Committee in its entirety;
- (C) The Meeting Chairman shall ask Monroe Miller to either admit or deny the allegations of the Petition, and
  - 1. In the event that Monroe Miller admits all of the allegations contained within the Petition to Consider Removal of Monroe Miller from the Haywood County Executive Committee, the Haywood County Executive Committee shall begin hearing evidence, testimony and arguments of the parties only as it relates to the issue of the appropriate sanction, including but not limited to the removal of Monroe Miller from the Haywood County Executive Committee; or
  - 2. In the event that Monroe Miller denies any or all of the allegations of the Petition to Consider Removal of Monroe Miller from the Haywood County Executive Committee, the hearing of the matter will proceed as to the allegations denied as follows;
    - a. Each side, by and through their respective Representatives, beginning with a Representative for the Petitioners, shall be afforded the opportunity to make a brief opening statement; (6 Minutes per side) The Meeting Chairman shall instruct the Members that statements made during Opening and Closing Arguments are not evidence for them to consider.
    - b. The Representative for the Petitioners shall present evidence of the charges of gross inefficiency and party disloyalty. The members of the Haywood County Executive Committee sitting in judgment may believe all, part or none of the evidence as presented, and shall determine what weight, if any, shall be given to the evidence contained therein. The Petitioners case may include witness testimony, sworn statements, documentary evidence and other relevant materials.
    - c. The Representative for Monroe Miller shall present evidence refuting the charges of gross inefficiency and party disloyalty. The members of the Haywood County Executive Committee sitting in judgment may believe all, part or none of the evidence as presented, and shall determine what weight, if any, shall be given to the evidence contained therein. The Petitioners case may include witness testimony, sworn statements, documentary evidence and other relevant materials.

- d. If either the Petitioners or Monroe Miller presents its evidence in the form of testimony from witnesses, each side will be afforded the opportunity to cross examine the witness(es);
- e. The Petitioners followed by Monroe Miller shall be afforded the opportunity to present rebuttal evidence;
- f. Each side shall be afforded the opportunity to present a closing argument; (6 Minutes per side)

### Deliberations after Evidence Presented Rule 4

- (A) Once all of the evidence has been presented, and each party has been afforded the opportunity to present a closing argument, Monroe Miller shall leave the meeting room, and the Meeting Chairman shall allow the voting members of the Haywood County Executive Committee to debate the allegations of the Petition, and whether or not Monroe Miller should be found to have committed the charges and specifications of the petition.
- (B) Debate in favor of, and against the charges and allegations shall be limited to 30 minutes per side.
- (C) No person, either for or against the charges and allegations, shall be permitted to address the Haywood County Executive Committee for a period of time not to exceed two (2) minutes.
- (D) Once debate has ceased, the Meeting Chairman shall present the following questions to the voting members of the Haywood County Executive Committee:

- (E) A member who votes for a finding that Monroe Miller committed one or more of the acts or violations as alleged in the petition should be morally convinced that Monroe Miller has committed one or more of the acts or violations on the basis of the evidence he or she has heard.
- (F) A determination that one or more acts of Gross Inefficiency and/or Party Disloyalty has been committed by Monroe Miller shall be made based upon a 2/3 vote.
- (G) A determination that Monroe Miller should be removed from the Haywood County Executive Committee shall be made based upon a 2/3 vote.
- (H) A determination that Monroe Miller's acts of party disloyalty, if any are found, should be referred to the State Executive Committee of the North Carolina Republican Party for further action shall be made based upon a majority vote.

### Voting Rule 5

- (A) Voting on the questions presented by the Meeting Chairman pursuant to Rule 4 above shall be by secret ballot. The issues presented shall be included on one (1) ballot. The Meeting Chairman shall distribute paper ballots to the credentialed voting members of the Haywood County Executive Committee, and shall be responsible for their collection and counting. The Petitioners and Monroe Miller shall be permitted to designate one observer, who shall be a member of the Haywood County Executive Committee.
- (B) Should the Haywood County Executive Committee determine that Monroe Miller has committed any of the acts or violations alleged in the petition, but not determine by a 2/3 vote that he should be removed from the Haywood County Executive Committee, the Haywood County Executive Committee may consider and vote upon on any other disciplinary sanctions to be imposed. A determination of any other sanction, other than removal, shall be by a majority vote.
- (C) Should the Haywood County Executive Committee determine that Monroe Miller has not committed any of the acts or violations alleged in the petition, the hearing is concluded and the body shall adjourn without taking further action.

### Adoption and Suspension of the Rules Rule 6

These rules shall be adopted by a majority vote of the members of the Haywood County Executive Committee, and may be suspended during the meeting by two-thirds vote of the members present, except that those rules contained herein which are drawn from the Plan of Organization of the North Carolina Republican Party may not be suspended. Roberts Rules of Order, Newly Revised, 11th Edition, shall govern this meeting in all

instances to which they are applicable, and in which are not inconsistent with these rules and the North Carolina State Republican Party Plan of Organization. Rules of the Haywood County Executive Committee Meeting shall be in conformity with the North Carolina Republican Party Plan of Organization.

I conspicuously placed my audio recorder in my shirt pocket, turned it on before the meeting, and met with the two deputies prior to entering the hearing building. I announced to both of them that I intended to record my hearing. They indicated, "We are just here".

At around 6:37pm, the meeting had not started yet, and Aubrey Woodard came over to me and invited me to leave, as I was not allowed to record the meeting. I suggested to him that it would take a Sheriff Deputy, not him, to make me leave the meeting.

In accordance with the North Carolina Republican Party Plan of Organization, this is an official notice of charges. It is alleged that you have committed one or more incidents of party disloyalty.

Through Resolutions passed by the Haywood County Republican Party and the 11th Congressional District Committee, the North Carolina Republican Party Executive Committee will consider these charges on November 11, 2017 at an Executive Committee meeting at the Embassy Suites in Cary, NC. An official meeting notice is enclosed.

It is alleged that you participated in efforts to support candidates other than Republicans during the 2016 election. In part, these allegations focus on the production, funding and distribution of an "official" Haywood County Republican palm card/sample ballot that supported a non-Republican candidate over a Republican candidate for a seat on the Haywood County Board of Commissioners.

You are presumed innocent of these charges until the NCGOP Executive Committee makes a determination of responsible or not. Should the committee find you responsible of these charges, you may be declared ineligible to hold office under the State Plan of Organization for up to five years.

As directed via the aforementioned petitions, the Office of the NCGOP General Counsel is preparing a pre-trial report in accordance with Roberts Rules of Order to be sent to the Committee. In the interest of fairness, we offer you an opportunity to submit a written response. The response must be limited to the charges. Irrelevant material may be stricken from materials prior to submission. Doing so or not doing so does not change your ability to present a defense on your behalf at the Committee Meeting on November 11<sup>th</sup>.

If you have received a letter of Trespass, you are permitted to attend the Executive Committee meeting during the portion discussing the charges and may be at the meeting location beginning at 12:45 p.m.

Pursuant to the Plan of Organization your General Counsel is charged with the responsibility of presenting charges brought forward from a County Executive Committee, or a Congressional District Executive Committee, by resolution alleging Party Disloyalty. Party Disloyalty is defined as:

"Any registered Republican attempting to influence or influencing the outcome of any election against a Republican candidate or Republican endorsed by the appropriate Republican Executive Committee or Legislative Caucus, other than by supporting an opposing Republican Candidate in a Republican primary..."

This policy appears to be designed to allow the Party to work together in an uncomplicated manner to support candidates selected through our primary process in general elections. It is done in order to keep the Party from suffering self-inflicted injury as a result of rancor between factions of the Party that may have strong disagreements. It underscores the purpose of the Party, which is to select elected officials that can govern at various levels of government, and who share a core set of values identified by the Party.

Enclosed is a group of documents which, along with other similar documents, or statements of individuals, will be presented at the hearing on Saturday. Each person charged was serving as an officer at the Precinct or County level when the act occurred. After all of the evidence is presented at the hearing, which will be done by the Party and by the individuals charged with Party Disloyalty, the NCGOP Executive Committee will be asked to determine by a two-thirds (2/3) vote whether those individuals charged committed Party Disloyalty. If the Committee decides that the individual committed Party Disloyalty, then the Executive Committee must decide the appropriate sanction, which is limited to declaring the individual ineligible to hold office under the Plan of Organization (which would include State, District, County and Precinct Offices) for a period of not less than six (6) months, and no more than five (5) years.

There are no other sanctions available to the Executive Committee. The person is still a member of the Party, and after expiration of the period may run and hold office under the Plan of Organization. We will try to present information which supports the charge, or is relevant on the issue of the appropriate sanction, to you in the most efficient manner. The matter is scheduled to be heard at the State Executive Committee hearing on November 11, 2017.

# INTRODUCTION: PARTY DISLOYALTY

From time to time, the General Counsel's office is charged with prosecuting an action referred to the members of this State Executive Committee. In some instances the General Counsel's office is charged with prosecuting Party Disloyalty, defined as:

Any registered Republican attempting to influence or influencing the outcome of any election against a Republican candidate or Republican endorsed by the appropriate Republican Executive Committee or Legislative Caucus, other than by supporting an opposing Republican Candidate in a Republican primary...

A charge of Party Disloyalty may be brought before the State Executive Committee by fifty members of the State Executive Committee, or by resolution of either a County or District Executive Committee. In this instance, your State Party has received two resolutions concerning the same five individuals. These resolutions come from the Haywood County Executive Committee, and the Eleventh Congressional District Executive Committee.

# INTRODUCTION, CONT.

The Executive Committee must determine for each person charged, whether they committed Party Disloyalty as defined by the 2017 State Plan of Organization. If you find it more likely than not that an individual committed party disloyalty by a two-thirds (2/3) vote, you may then consider the sanction to be imposed. The only sanction available to you, regardless of the seriousness of the wrongful act, is to declare the person ineligible to serve in any office under the Plan of Organization for a period of not less than six (6) months and not more than five (5) years.

This matter must be handled in the strictest confidence. You are not to discuss the matter with anyone who is not a member of the State Executive Committee, or to disclose any of these materials. After the Executive Committee completes its work, it will make a public statement as to the outcome of this proceeding through the Chairman or the Executive Director.

# INTRODUCTION, CONT.

What follows are some of the documents which indicate the substance of the charges, as well as additional matters concerning the conduct of these persons which may weigh on consideration of the penalty, if any, the State Executive Committee wishes to impose.

You will be provided with a copy of some of the materials which will be presented, so that you may familiarize yourself with them as they are presented to this Committee. Thank you for your attention to this important task.

# **CONCLUSION:**

This behavior is in clear violation of the 2017 State Plan of Organization:

Any registered Republican attempting to influence or influencing the outcome of any election against a Republican candidate or Republican endorsed by the appropriate Republican Executive Committee or Legislative Caucus, other than by supporting an opposing Republican Candidate in a Republican primary...

It is your duty as members of the State Executive Committee to charge the offenders with violation of the foregoing provision. Should you do so by a two-thirds (2/3) vote, you may then consider a sanction for each offender which would render them ineligible to serve in any office under the Plan of Organization for a period of between six (6) months and five (5) years

# Ousted Haywood Republicans face party disloyalty charges

Five Haywood conservatives labeled as trouble-makers by the GOP establishment are facing charges of party disloyalty.

Disloyalty charges are a final check mate in the ongoing tug-of-war for control of the Haywood County Republican Party, which has been stereotypically characterized as the mainstream branch of the party versus a dogmatic activist faction. Those facing charges include Jeremy

Davis, Richard West, Monroe Miller, Paul Yeager and Eddie Cabe — all of whom were overthrown from leadership roles in the local party earlier this year.

A hearing on the disloyalty charges will be held by the N.C. GOP executive committee in Raleigh this Saturday, with a decision expected that day. Party disloyalty charges are incredibly rare.

"We regret any action like this being taken. It is not something that we like, and it is not something that normally occurs. But occasionally from time to time arise certain situations where actions must be looked at," said Aubrey Woodard, the regional GOP party chair for 11<sup>th</sup> Congressional district.

The charges allege that the so-called Haywood Five advocated against Republicans on the ballot in the 2016 general election. If the charges stand, they would be barred from holding office or leadership positions within the party for up to five years.

To supporters, the so-called Haywood Five are unwavering ideologues upholding true conservative values — rejecting Republican candidates or party leaders who don't meet their conservative purity test.

"When you cut through all the crap, our crime was that we were expecting conservatives to be conservative. That's really what they've got us on," said Jeremy Davis, one of the Haywood Five. "We wanted Republicans to vote in accordance with the Republican platform, and they are trying to throw us out of the party for it. That's hypocritical in my opinion."

But to critics, the Haywood Five are rabble-rousers who use name-calling, ridiculing and public embarrassment as a political weapon against Republicans who aren't on their side. The behavior has run the gamut from lewd and suggestive videos circulated online, cyber harassment and even physical intimidation.

The Haywood Five have already been ousted from leadership roles during a take-back of the party by mainstream Republicans earlier this year.

The dogmatic faction had infiltrated the party's core over the past four years, but mainstream Republicans pulled off a surprise coup at the party's annual convention back in February and voted out more than a dozen members of the activist faction from their precinct chair positions.

Davis believes the disloyalty charges are aimed at preventing them from coming back and regaining control of the party again since they would be prepared for a showdown over precinct chairs the next time around.

<sup>&</sup>quot;That's a one-trick pony," Davis said of the coop.

Indeed, keeping the Haywood Five out of party leadership roles would be the main consequence if the charges stick.

"They could not reclaim positions they had in the party for up to five years," explained Dallas Woodhouse, executive director of the N.C. GOP.

Following their ouster, the dogmatic faction started a new political action committee called the Haywood Republican Alliance. While Davis plans to fight the disloyalty charges, he said he doesn't particularly care if he gets banned from roles within the party.

"I'll be perfectly honest with you. If the power structure stays the way it is now, I have no wish or desire to go back into the Republican Party. I am more effective right here," Davis said, sitting in the headquarters of his Haywood Republican Alliance last week.

#### West agrees.

"We are winning the battle anyway," said West, citing the activities of the new Haywood Republican Alliance.

Yeager believes the party establishment feels threatened by the Alliance.

"I think that the Haywood County GOP leadership was surprised when we failed to just give up on political activism after they electioneered several of us off the HOGOP executive committee," Yeager said. "They appear to have made interfering with us a major goal since then."

One of the faction's ring-leaders, Monroe Miller, managed to survive the coup earlier this year and hang on to his seat as a precinct chair. He was subsequently ousted anyway for allegedly trying to wreck the party from the inside by undermining the credibility of its leadership.

"Miller frequently publishes articles on his blog in which he demeans, ridicules, and attempt to embarrass the leadership of the Haywood County Republican Party," according to a resolution calling for Miller's removal. "Miller frequently sends copious emails to large groups in which he attempts to make the HOSOP leadership look incapable, inefficient or even dishonest."

#### Grounds for disloyalty charges?

It is unknown at this point exactly what hard evidence will be presented against the Haywood Five for allegedly supporting candidates other than Republicans in the 2016 general election.

"This should be considered a trial-like situation. So I can't speak to any of the evidence of that nature," Woodard said. "They will be extended every opportunity to present the rebuttal or defense as it may be. We will make sure everything is done correctly and honestly and above board."

Simply being trouble makers isn't official grounds for party disloyalty. But directly advocating against Republican candidates is a no-no for anyone in a party leadership position, per GOP party rules.

"It is alleged that you participated in efforts to support candidates other than Republicans during the 2016 election," reads a letter from the state party to the Haywood Five in early October informing them of the disloyalty hearing.

But Davis said the Haywood Five hasn't received any hard evidence to that effect.

"I have asked and asked 'Can you tell me what evidence you have a against me so I can prepare a defense,'" Davis said. "As I can attest I haven't done these things it must be falsified or fabricated."

Inside the disloyalty hearing

Only two of the Haywood Five — Davis and Yeager — plan to go to the hearing to present a defense in person. The rest of the Haywood Five believe it is fruitless to attend.

"It wouldn't make a difference. The deal is cooked," said West.

Although Yeager is going, he agreed it might not do any good, saying the Haywood GOP leaders have "apparently found sympathetic ears with no desire to hear more than one side of the story."

Ironically, three of the Haywood Five have been issued trespass warnings from the N.C. GOP banning them from GOP functions and property — namely Davis, Yeager and Eddie Cabe. But the trespass ban will be waived for the hearing.

"If you have received a letter of Trespass, you are permitted to attend the meeting during the portion discussing the charges," states a letter from the state party to the Haywood Five members.

The hearing will be held during the regular business meeting of the N.C. GOP statewide executive committee, comprised of more than 500 members from local GOP chapters all over the state. Only between 250 and 350 will likely attend the state business meeting this weekend.

For the charges to stick, they must be approved by a two-thirds vote of those present.

It's unclear how the issue will be received by the executive committee. On the surface, it could appear to be a spat best settled at the local level. But it is also a precedent-setting test for how the party will handle the widening gap between far-right extremists and moderates.

### How we got here

The disloyalty charges were initiated in May by the Haywood GOP executive committee, comprised of 30 precinct chairs and at-large officers. This is the same body that the Haywood Five and their compatriots had been ousted from just three months prior.

The Haywood resolution was then sent up the chain to the 17-county GOP regional body, which mirrors the 11<sup>th</sup> Congressional District.

Woodard polled the 11<sup>th</sup> district executive committee by mail, asking them to endorse the idea of sending the charges on to the state party.

"Many of you know the long standing issues the NCGOP has had with the now former leadership of the Haywood County Republican Party," Woodard wrote. "It is important that the district be supportive of our county organizations. Please help us address this serious issue by signing the enclosed petition."

A self-addressed, stamped envelope was included.

"The responses were overwhelming as far as the individuals taking the time and energy to respond," Woodard said.

After receiving the resolution from the Haywood GOP and the petition from the 11<sup>th</sup> District GOP, the state GOP was obligated under procedures in the Party Plan of Organization to address the allegations.

"Either one of those two actions would put this matter in front of the state executive committee, who is really the only one that can determine issues of party disloyalty," Woodhouse explained. "At the end of the day, it would be up to members of the executive committee where they go and what decisions they make and whether they make a finding."

Each of the five members facing accusations of party disloyalty will be voted on separately.

- 2. Based thereon the North Carolina 11<sup>th</sup> District Republican Party Executive Committee to take the strongest possible actions pursuant to Article VII.E.2. of the North Carolina Republican Party Plan of Organization.
