## Town of Waynesville, Board of Alderman Meeting.

There was a regular meeting of the Town of Waynesville Board of Aldermen (and woman) on 10/12/2021 at 6pm. Item D., 2., on the agenda was a presentation by "Facilitator" **Amy Murphy-Nugen** (a.k.a. Down Home NC Hack). Nearly every seat was occupied. The subject was:
