- A full time “Navigator” position,
- A full time “Thru Care” position.

I have made a Request for Public Information to **Joey Webb**, IT Department, for all of the emails **Rick Marvin** has either sent or received on his county assigned email address of: [rick.marvin@haywoodcountync.gov](mailto:rick.marvin@haywoodcountync.gov).

This request has been obstructed by **Frank Queen**, Haywood County Attorney (through the pawn **Joey Webb**) for the following reasons:

- According to NCGS § 132-2 the Sheriff, being the public official in charge of the office, is the custodian designated for this particular request and is responsible for ensuring that all information released is compliant with Federal and State laws or regulations.
- It is my belief that in the course of their duties, Ms. Deering and Mr. Marvin may be routinely exposed to information which is protected under the Health Insurance Portability and Accountability Act of 1996 (attached for your reference), and said information therefore, must be redacted by the Sheriff or his designee.
- It is also my belief that in the course of their duties, Ms. Deering and Mr. Marvin may be routinely exposed to Criminal Justice Information (CJI) which is protected under the CJIS security policy, which integrates presidential and FBI directives to govern the protection of said information.

This resulted in my filing a Grievance against **Frank Queen** with the North Carolina Bar Association.

It is my belief that county officials and officials from the Sheriff's Department have had an opportunity to examine these emails from **Rick Marvin**, and have determined that this will be a train wreck if released.

So how does this influence my decision and recommendation on who to vote for the next Haywood County Sheriff?

My thinking is that if someone currently inside the Sheriff's department wins the primary (Tony Cope), that this obstruction to release of emails will likely continue. While on the other hand, if someone wins who is not currently inside the Sheriff's Department (i.e. Bill Wilke), it is more likely that this whole Secret Peer Consultant Specialist Program may get a fresh look.
